b. Fire Boat 291 Repairs - Discussion / Action Item

CHIEF MATUE pointed out that the bids from Lake City Marine do not include pump repair. **COMMISSIONER BJELLAND** stated they think the pump is in good condition, it's a well-known brand.

VICE CHAIRMAN HANSON stated he had heard it said that this boat is not stable, is that true? **COMMISSIONER BJELLAND** assured him that was not true, it was the pontoon boat that was not stable because it would get over loaded.

CHAIRMAN MUNDT does not think it is under power, **COMMISSIONER BJELLAND** agrees, we do not need more power. This boat does not have a true swim platform, but that is not our mission quite honestly, that is the mission of the Sheriff's Marine Division, to do search and rescue.

CHAIRMAN MUNDT moved to approve Lake City Marine's quote in the amount of \$20,640.00 for a new 5.7 motor. **COMMISSIONER BJELLAND** 2nd.
