f. Levy Override - Discussion / Action Item

- Property values go up and our levy rate goes down.
- In 2000 the district started out at .95 per 1,000 of assessed value, the budget we just approved our levy rate will be .20 per 1,000 of assessed value.
- CHAIRMAN MUNDT stated a levy raise is coming but when is the right time to do it.
- CHIEF MATUE is worried that our savings will not last very long. We are coming up on a Union negotiation next year.
- CHAIRMAN MUNDT would like to gather information and numbers to present to the community, we need to create a plan and that is going to take time, we don't want to create a bunch of animosity in the community. We don't want to create an opposition group.
- VICE CHAIRMAN HANSON agrees, we also need to include the number of calls and our staffing for emergency responses. Without an increase we might have to cut staffing.

How-long-will the increased levy-rate be needed if the impact-fees become part of the revenue.
 CHAIRMAN MUNDT does not think the impact fees are going to save us.

COMMISSIONER BJELLAND we need to establish what has changed over the years and

explain it to the community.

 Lee Toedter asked the question; have you built in any reserves for your budget? VICE CHAIRMAN HANSON stated that we can only increase our revenue budget 3% each year, that is all we have to work with.

• CHIEF MATUE stated he had talked to a company that will help us with the levy override. Help

with the do's and don'ts and putting together flyers for \$2,000.00.

Leave this on the agenda for further discussions and let's gather more information for brochures, flyers and investigate doing a You Tube presentation to post on our website to get the information out to the community.
